



Louisiana Rural Water Association Advertising Agreement Information

(Non-members of LRWA)

The Louisiana Rural Water Association (LRWA) has a magazine that is printed 4 times a year (March, June, September, and December). The Magazine has a circulation of approximately 1550. The magazine is mailed to all LRWA members (rural water and wastewater systems, individual members, & associate members) other state associations, state and federal legislators, and water-related agencies. The overall size of the LRWA magazine is 8 1/2" w x 11" h and has approximately 64 pages.

LRWA **does not** typeset any advertisements. You must provide LRWA with camera-ready artwork. Camera-Ready artwork is defined as composite film for four-color advertisements and black and white art for one and two-color advertisements. If artwork supplied by any advertiser is **not** camera ready your company will be required to submit new artwork. If LRWA does not receive replacement artwork before deadline, advertisement will be placed in next issue of magazine. If you should have any changes/corrections to your ad, you must resubmit a new ad with the corrections; LRWA cannot make changes/corrections to advertisements.

All advertisements should be correct size. PDF format, Tiff, EPS, Quark Express 4.0 for MAC or PC. They must include all associated graphics and fonts. Please provide a good printed copy of the advertisement.

All artwork becomes the property of LRWA unless otherwise agreed upon by LRWA and advertiser.

The advertiser acknowledges that cancellations must be received in writing thirty (30) days prior to the advertisement deadline. Cancellations will not be accepted after the advertisement deadline; the ad will run in the current magazine issue and the advertiser will be responsible for payment.

A signed Advertising Agreement Form, payment in full (LRWA does not accept Credit Cards), and artwork must be received in the LRWA's office by the advertising deadline (see below for dates). Advertising received after the deadline is not guaranteed to print in current magazine issue unless pre-arranged with Angela Hargrave at the LRWA office.
